**NOTE**

1. In addition to the mentioned fares in Table 1 and Table 2, The taxes mentioned in the Table no 3 will be also added (Aviation Security Fee (ASF), CUTE charges, User Development Fee (UDF) and GST will be charged on the applicable Routes.
2. All payments made on Star Air website, Call centre and Airport ticketing counters shall attract an additional non-refundable Convenience Fee of Rs.350. (or equivalent amount in other currencies) from each passenger (per pax per leg) traveling on Star Air flight.
3. Star Comfort Fares are available on the website with an additional amount of INR.1750 on the Regular Fares. Star Comfort fare will be bundled with complimentary meals and beverages.
4. Star Flexi are available on the website with an additional amount of up to INR.750 on the Regular Fares. Star Flexi product will be bundled with one free date change with no change fee. Additional fare difference needs to be paid.
5. Infant Fare INR.1750 is charged in economy class cabin.
